

USER AGREEMENT FOR WWW.FREELANTION.COM (LAST MODIFIED ON NOVEMBER 8, 2011)

www.freelantion.com is an international freelance service, which runs on web and offers research projects which can be completed and delivered remotely .

THE FOLLOWING DESCRIBES THE TERMS ON WHICH WWW.FREELANTION.COM OFFERS YOU ACCESS TO ITS SERVICES.

Acceptance of User Agreement

The terms "You", "Your", "User" or "Users" refer to anyone accessing www.freelantion.com ("Site") for any reason.

This agreement ("User Agreement" or "Agreement") is a contract between you and Global Freelance S.A., 747836-2049836 ("we" or "us"). The access to the Site is offered to you conditional on your acceptance of the User Agreement. If you do not agree to any of these terms and conditions, you should immediately cease to use the Site.

Global Freelance S.A. may modify this User Agreement completely or partly, by posting an amended User Agreement on the Site. Such updated version of the User Agreement will be effective since the time it is posted on the Site.

This Agreement does not purport to be comprehensive and describes the most general issues concerning interaction between user and us, and therefore can't be considered as the only source, which regulates abovementioned interaction.

Opening Account

To become a User you must register for an "Account".

Terminating an Account

You can stop using Account any time on your own discretion.

User Accounts that have been inactive for more than 180 days will be terminated independently on whether their balances are positive or not.

Note that we may terminate or limit your access to www.freelantion.com account and/or limit access to your funds if you carry out activities, which contradict this User Agreement. We are also entitled to do that at any time if we, in our sole and absolute discretion, are concerned by any feedback about you, or your rating is considered problematic to www.freelantion.com in any sense without obligation to give any explanations.

No Warranty

Site, its content and functionality are provided on an “as is” basis, without warranties of any kind. Without limiting the foregoing, Global Freelance S.A. does not warrant that the Site will be uninterrupted, secure or error-free, free of viruses or other harmful components.
